- When and to whom possible incidents of communicable disease or infections should be reported.
- Standard and transmission-based precautions to be followed to prevent spread of infections.
- When and how isolation should be used for a resident; including but not limited to:
 - The type and duration of the isolation, depending upon the infectious agent or organism involved
 - A requirement that the isolation should be the least restrictive possible for the resident under the circumstances. An antibiotic stewardship program that includes antibiotic use protocols and a system to monitor antibiotic use.

- A system for recording incidents identified under the facility's IPCP and the corrective actions taken by the facility.
- Annual review. The facility will conduct an annual review of its IPCP and update their program, as necessary.
- Inform residents, their representatives, and families of those residing in facilities of confirmed COVID-19 infection, or three or more residents or staff with newonset of respiratory symptoms occurring within 72 hours of each other.


